Dear Mr. Petrovski

GoSafe Pest Control is pleased to submit the following proposal for continuing pest control services at the above location. **GoSafe** proposes 2x monthly service to treat entire restaurant main floor and basement level for rodents and crawling insects at the above reference address. The cost for 2x month service is proposed at \$200 plus tax, per service.

The initial service is offered at \$325 plus tax and includes the initial interior treatment for crawling insects and rodents, inspection and sealing of all visible holes, placement of traps, snap traps as needed. Mechanical traps (8each) will be ordered for an additional \$160 plus tax and will be placed throughout facility kitchen, bar, utility/ storage areas.

- A. PEST(S) TO BE CONTROLLED:** Pests covered under this service agreement include: Mice, Rats, Common Ants, Crickets, Earwigs, Flour Beetles, German Roaches, Ground Beetles, Grain Moths, Millipedes, Silverfish, Carpenter Ants, Centipedes, Sow Bugs, Spiders, Water Bugs/American Roaches, Oriental Cockroaches.
- The pest control technician will check with the person designated by Marlow Bistro manager. Services will be rendered upon the agreed designated day/time.

SPECIAL INSTRUCTIONS

1. It is understood that the following proposal does not include treatment for: Fleas, Carpenter Bees, Termites, Flies, Stink Bugs, Bed Bugs, fabric-grain-parasitic-wood-destroying insects, rats on exterior of the buildings, bees/wasp on exterior of buildings, birds and fur-bearing animals (e.g., squirrels and raccoons).
2. **GoSafe Pest Control** reserves the right to review the monthly charges after one year of service. In the event of a price change, **GoSafe Pest Control** will submit a letter to Marlow Bistro Management for agreement renewal by mutual consent.
3. Any additional service request for pests mentioned in section "A" will be calculated at the current rate. Services are available for pests not covered by this contract (1) and will be offered at a discounted rate to **GoSafe Pest Control** customers.
4. GoSafe Pest Control will provide all necessary certificates of insurance upon request.
