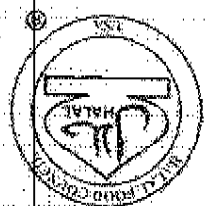

4. Halal product Boxes to have Halal Food Council's stickers
5. This certificate applies only to the raw slaughtered products and not for any further processing or restaurant.

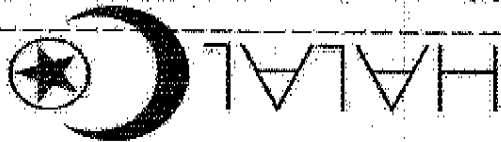
