CMR:

Botanisil CPM-10 does not contain any intentionally added composition components classified as carcinogenic, mutagenic or toxic for reproduction (CMR) as defined in Directive 1272/2008. None of these substances are expected to form during manufacture and are not expected to be present in Botanisil CPM-10 except as unknown impurities at trace levels.

European Cosmetic Directive

Synthetic Polymer Microparticle:

“Synthetic polymer microparticle” is defined in the September 2023 Commission Regulation (EU) 2023/2055 amendment of Annex XVII to Regulation (EC) No 1907/2006. When evaluated against the definition cited within the regulation, Botanisil CPM-10 does not contain synthetic polymer microparticles. We do not expect the product to fall within the scope of the proposed restriction. Botanigenics does not analyze for the presence of synthetic polymer microparticles in Botanisil CPM-10.

It remains the responsibility of the end user to comply with the final microparticle regulation for the finished products they are placing on the market.

Volatile Organic Content:

None of the components in Botanisil CPM-10 are classified as a VOC.
